PBC has been approached by James Sneddon to help with a 3 Sport pilot in Middle Schools - Pickleball, Volleyball, Badminton. One of the outcomes will be a manual for teachers to deliver the 3 sport. As a preliminary step, I have E contacted James and asked him several questions to share info. Here's what we've talked about to date. He has also been talking to a point person at BC Badminton.

- Project Grants: (a.) Develop criteria and intended outcomes for proposed Youth Initiatives Grants (b.) Implement Grants 2021 monitor, assess lessons learned, and make recommendations for 2022

## 9. Gaming Grant - Sharon

Zoom meeting on the Community Gaming Grants Program.

It was very informative and applied to all Gaming Grants not just Sports.

There is an application process on their website that is very comprehensive with examples of how to fill out the necessary forms.

Basically, Denise Mahon who was the presenter wanted applicants, past

and future to know that there were some modifications due to CoVid 19.

These modifications were to extend the 12 month period to spend the funds that were received last year, so basically they were given 24 months to spend the funds. Also, all clubs who were unsure about half spent, or not spent funds were encouraged to contact her so she could clarify.

The Program is trying to accommodate all the special needs that the CoVid virus has caused.

Also in attendance and giving a short introduction were Charlene Krepiakevich - CEO of ViaSport and Scott Stefani who fielded the Q&A at the end of the presentation.

## Dedicated Pickleball Court Resources Area for PBC Web Site Report

March 11, 2021

Currently in the phase of collecting and collating information. Projecting to have items to publish on the PBC website for the fall of 2021. Also participating with two groups one with Tennis BC, and one group focusing on private dedicated pickleball court development to assist in this project.

#### 13. **PSO/COVID** - Karen

## **COVID** report

PBC continues to receive daily questions and suggestions from around the province. Communication includes the concern over breaches to the outdoor doubles rule, emails advocating for the changing of the outdoor doubles order, questions about one home club rule, questions looking for loop holes and others asking PBC to intervene and advocate on behalf of BC pickleball players for the approval of outdoor doubles play. We respond to each email.

PBC has aggregated the email themes and shared them with viaSport. We have also suggested that outdoor doubles Pickleball play should be

considered a low/no risk sport activity for covid transmission and as such only 2 meters of distancing on the court should be recommended.

## **Provincial Sport Organization Report**

ViaSport reported that once the 5 policies for
